#### 7. Council Elections

#### a) Declaration of all positions on the Council vacant

Under ASR Rule 50, all positions are to be open for election.

#### b) Election of the new Council

Election of the Officers Holders (*President, Vice President, Secretary, Treasurer, Webmaster*) and ordinary members of Council — total positions may be up to 12.

#### 9. Subscriptions

#### a) Fees

It is proposed that current fee provisions shall continue to apply:

- There is no joining fee for any class of member.
- Annual membership subscription fees are 44 AUD for full members, and 22 AUD for student members.

New members joining after the start of a financial year may pay a lesser amount at the discretion of the Council, in accordance with ASR Rule 12(3).

#### b) Date for payment of the annual subscription

It is proposed that annual subscriptions for existing members shall be paid within a period of 90 days after the AGM that marks the beginning of the term, while new members may join at any time.

#### c) Privileges

ASR Rule 12(5) applies: "The rights of a member (including the right to vote) who has not paid the annual subscription by the due date are suspended until the subscription is paid." [*For information only*.]

#### **OTHER BUSINESS**

ASR Rule 30(5): The annual general meeting may also conduct any other business of which notice has been given in accordance with these Rules. Note: General business may be considered at the meeting if it is included as an item for consideration in the notice [...] and the majority of members at the meeting agree
